Elections Act 2022

The Elections Act 2022 received Royal Assent on 28th April 2022. This ensures that UK elections remain secure, fair, modern, inclusive and transparent. The UK Government is making changes to the UK Electoral system. The Act contains measures that affect the elections and the way we vote, campaigning and the rules on campaign spending and funding, parliamentary oversight of the Electoral Commission.

From 4th May 2023, all voters will need to show photo ID at all polling stations. Accepted forms of Photo ID are:

- Passport
- Driving (this includes a provisional) Licence
- A Blue Badge
- Bus Passes

If your ID is out of date, you can still use it as long as it looks like you. The name on your ID should be the same you registered to vote.

If you don't have the correct form of ID then you can apply for a free Voter ID document called a "Voter Authority Certificate". You will need to register to vote before applying for this. The deadline to apply for a Voter Authority Certificate is 5pm Tuesday 25th April 2023.

CODE OF RECOMMENDED PRACTICE ON LOCAL AUTHORITY PUBLICITY (ENGLAND) / PUBLICITY DURING THE PRE-ELECTION PERIOD (purdah)

A code of recommended practice on local authority publicity ('The Code') was issued on 31 March 2011. By virtue of s.6 of the Local Government Act 1986, the Code applies to parish councils.

It is recommended that parish councils follow the Code, which is available via the following link: https://www.gov.uk/government/publications/recommendedcode-of-practice-for-local-authority-publicity.

Paragraph 28 of the Code says:

"Local authorities should not publish or incur expenditure in commissioning in hard copy or on any website, newsletters, newssheets, or similar communications which seek to emulate commercial newspapers in style or content. Where local authorities do commission or publish newsletters, newssheets or similar communications, they should not issue them more frequently than quarterly, apart from parish councils which should not issue them more frequently than monthly. Such communications should not include material other than information for the public about the business, services and amenities of the council or other local service providers".

Paragraphs 34 and 35 of the Code are set out below:

"During the period between the notice of an election and the election itself, local authorities should not publish any publicity on controversial issues or report views or proposals in such a way that identifies them with any individual members or groups of members. Publicity relating to individuals involved directly in the election should not be published by local authorities during this period unless expressly authorised by or under statute. It is permissible for local authorities to publish factual information which identifies the names, wards and parties of candidates at elections.

In general, local authorities should not issue any publicity which seeks to influence voters. However, this general principle is subject to any statutory provision which authorises expenditure being incurred on the publication of material designed to influence the public as to whether to support or oppose a question put at a referendum. It is acceptable to publish material relating to the subject matter of a referendum, for example, to correct any factual inaccuracies which have appeared in publicity produced by third parties, so long as this is even-handed and objective and does not support or oppose any of the options which are the subject of the vote".

Its clear that Local Councils should look to postpone any expenditure around big ticket items or delay any major new decisions until after the May elections where possible. However, not at the expense of any significant additional expenditure (e.g., contractual) or reputational damage that may result. Purdah was never designed to derail your regular business. Therefore, anything that is a regular item or usual business that is underway will be acceptable. In terms of individuals: the chairman will set a good example by ensuring that they do not grandstand or take advantage; particularly around projects and members should be wary of promoting themselves as individuals and at all points the approach should be neutral and toned down during this sensitive period.

In addition, member councils should also consult their local Electoral Registration Officer (Democratic Services) at their district council (or unitary authority) to ascertain any local guidance and advice. Please see your district council website.

NALC Updates

1,000 local councils sign the Civility and Respect Pledge

<u>1,000 local (parish and town) councils have now signed up for the Civility</u> <u>and Respect Pledge.</u> Launched just six months ago as part of our <u>Civility</u> <u>and Respect Project</u>, the Pledge demonstrates that councils are committed to standing up to poor behaviour and driving through positive changes that support civil and respectful conduct. And the more councils that <u>sign the</u> <u>Pledge</u>, the more impact it will have in lobbying the government to re-visit its response to the Committee on Standards in Public Life report on local government ethical standards. Can I urge all councils yet to sign the Pledge to do so.

New suite of e-learning on civility and respect

The Civility and Respect Project has also launched <u>a new suite of e-learning</u> <u>courses for local councils.</u> We recognise that webinars and training courses only sometimes suit the busy schedules of local councils. Yet e-learning allows councils to respond quickly to learners' needs, with flexibility and without having to organise physical training with fixed dates and times. The new courses are on standards in public life, respectful and positive social media for councils and councillors, leadership in challenging situations, and personal resilience.

News from NALC



The National Association of Local Councils (NALC) has urged the House of Lords to make essential changes to the Levelling Up and Regeneration Bill to ensure local (parish and town) councils play their part in levelling up and improving local communities.

NALC president, Baroness Scott of Needham Market, has put forward a package of amendments for peers to consider, which seek to address many of the most pressing issues the sector faces that are within the remit of the Bill. They include

- · For councils to be able to hold remote meetings
- Suspension of councillors who breach the code of conduct
- Access to direct government funding and grants
- A timetable for the neighbourhood governance review to make it easier to set up new local councils
- · Payment of dependent carers allowance to councillors
- The extension of the General Power of Competence

NALC has sent a briefing in support of the amendments to one hundred critical contacts in the House of Lords, urging them to support Baroness Scott during the Committee Stage of the Bill over the next few weeks.

Cllr Keith Stevens, NALC chair, said: "We are extremely grateful for Baroness Scott's work to promote these changes to this important levelling up Bill. If adopted, they will make a significant difference to the ability of NALC's 10,000 local councils and 100,000 councillors. I urge the House of Lords and government members to consider them seriously."

Aimed at local sports clubs and community groups that are in need of some funding? Applications are still open for Active Kent and Medway's - Everyday Active small grant scheme until the end of March 2023!

Funding is available for projects that deliver things like new activity programmes or community events designed to re-engage with their previous audience and/or encourage those new to activity to be active. Funding can be used for things like the cost of equipment, venue hire, coaching and the promotion of sessions.

Green Initiatives

Adapting to Climate Change and Flooding -The Flood and Water Management Team has secured £115,000 of funding from the Environment Agency Flood Defence Grant in Aid and Local Levy, to deliver a culvert replacement scheme at Catts Place near Paddock Wood. The scheme will deliver approximately £250,000 of benefits by protecting 11 properties from flooding.

Book reuse at the Household Waste Recycling Centres - Book donation banks are being rolled-out across the network of HWRCs. Customers will now be able to leave their books for reuse in a dedicated container, rather than sending them for recycling or energy recovery. The books are sent to the Precycle Group to be checked and if they can still be read, they will be sold to retail and wholesale customers

SolarTogether

From 20 March, residents will be able to register for the third round of Solar Together, the scheme which uses collectivebuying power to bring down the price of solar PV (photovoltaic) panels. Vetted solar installers compete in a reverse auction (lowest price wins) to win the contract to supply and install solar panels. The scheme is open to residents, small to medium sized enterprises and commonhold associations. Registrants can expect to receive a quote in June and have a 4-week period to decide if they want to proceed.

All 12 district councils, KCC and Medway are supporting the scheme and sending letters to over 50,000 households in March, to encourage the uptake of this renewable energy and reduce the carbon emissions from homes across Kent and Medway.

The second phase of the scheme, which launched in March 2022, is almost complete, with over 1,350 homes installed and another 150 booked for installation. This is over six times the number of installations completed in Phase 1. As demand is expected to remain high this year, the third phase, running this year, will be split into 2 auctions, in spring and autumn. This will spread installations more evenly across multiple installers throughout the year and reduce the wait time for some residents.

The scheme will be promoted via the councils' newsletters and social media platforms and there will be e-posters and other promotional materials available for you to share with your communities. You can contact KES@kent.gov.uk for these resources.

National No Smoking Day 8 March 2023

In preparation for No Smoking Day on Wednesday 8 March 2023, ASH (Action on Smoking and Health) has created a new <u>communications toolkit</u> to support your local quit smoking marketing activity.

The theme for No Smoking Day this year is brain health and the link between smoking and dementia. ASH has been working with Alzheimer's Research UK in development of the toolkit whose research demonstrates low awareness amongst smokers of the increased risk of dementia caused by smoking. The campaign will encourage smokers to 'never give up giving up' and signpost them to the <u>NHS Better Health Quit Smoking</u> website which includes a wealth of information and support to help smokers on their quitting journey.

ASH will launch their PR and social media activity on 22 February, running through to No Smoking Day on 8 March. Additional materials will be added to the toolkit in the next few weeks including the national press release (with regionalised versions which you can use locally) along with a video featuring a dementia expert.

There's also a range of free quit smoking resources available on the DHSC Campaign Resource Centre to support ongoing quit smoking activity.
